- 6. Parties are further reminded to upload their Practice Notes and the Plaintiff's Founding Affidavit/ Plaintiff's Evidence Affidavit.
- 7. Parties must ensure that the files on CaseLines comply with paragraphs 7 and 30 of the Revised Consolidated Practice Directive 1/2024 and any other paragraphs that may be relevant to the matter by 10h00 on Thursday 30 October 2025, failing which the matter is at risk of not being dealt with.
