# <u>DIRECTIVE FOR DEFAULT JUDGMENTS TRIAL COURT PROCEEDINGS BEFORE THE HONOURABLE ACTING JUSTICE VAN DER MERWE FOR WEEK 27 October 2025 – 31 October 2025</u>

- 1. All matters will be heard in open court at 10:00. The court number will be published on the daily roll. Introductions in chambers are not necessary.
- 2. One hard copy of the draft order (headed "court order") must be available at the hearing of the matter to be handed up. Please make sure there are no typographical errors on the drafts before they are handed up in Court.
- 3. Draft orders in PDF and Word format must be uploaded timeously and must reflect the presiding judge's name on the draft order.
- 4. Removals and settlements will be called first on Tuesday. Thereafter for the remainder of Tuesday, matters may be called according to the seniority of counsel.
- 5. On Wednesday and Thursday the remainder of the matters will be heard by the number they appear on the roll.

- 6. <u>Matters that have become settled</u>: A separate profile called SETTLEMENT BUNDLE must be created containing the following:
  - \* Offer and acceptance
  - \* Confirmation letter in respect of draft order
  - \* Draft order
- 7. In the event of a removal:
  - CREATE A REMOVAL FOLDER AT THE TOP OF THE CASELINES PROFILE,
  - A draft order must be uploaded and a hard copy of the draft order for removal must be available at the hearing of the matter.
- 8. In the event of a removal or postponement, the judge's registrar must be informed timeously, in order to inform the judge not to read the papers. RMahori@judiciary.org.za
- 9. All Heads of argument must be uploaded by 14h00 on Friday 24 October 2025.
