## DIRECTIVE BY THE HONOURABLE MADAM JUDGE TOLMAY

- 1. The proceedings will be conducted in OPEN COURT at **10:00 am**. Please consult the day roll for the court room number.
- 2. Introductions will be in chambers in office 148, Palace of Justice at 09h30am.

- 3. In all applications, parties must ensure that all relevant papers are filed (i.e notice of set down, practice notes and draft order). No additional papers may be uploaded to case lines without the permission of the Honourable Judge. Requests to upload further papers must be send to <a href="mailto:TPeele@judiciary.org.za">TPeele@judiciary.org.za</a>.
- 4. With matters not displaying on case lines, parties must ensure that the Honourable Judge's Secretary is invited on the matters timeously before the date of hearing.
- 5. The master bundle must be properly indexed and paginated, annexures must be clearly marked and separated. Failure to adhere to this will result in your matter being removed from the roll.
- 6. Only one draft order is to be handed up, clearly reflecting the Honorable Judge's name (Honorable Madam Judge Tolmay), date and court room number.

#### 7. UNOPPOSED DIVORCES AND RULE 43:

- 7.1. Unopposed divorces and rule 43 matters will be heard on Monday 13

  October 2025 in open court, subject to the provision as set out hereinunder:
  - 7.1.1 In divorce matters in which there are no minor children, no appearance will be required, and the matters will be decided on the papers. A Legal Representative must be present to move the application.

- 7.1.2 In such matters the plaintiff must ensure that all the relevant affidavits have been filed and that the draft order and the settlement agreement is uploaded timeously on case lines.
- 7.1.3 In divorce matters where minor are children involved, the plaintiff (or defendant, if applicable) must appear in court and provide oral evidence.
- 7.1.4 Witnesses are urged to dress suitably.
- 8. There will be roll call in open court on **Tuesday 14 October 2025 at 10h00am** where the remaining matters will be allocated.

#### 9. URGENT APPLICATIONS:

- 9.1. Urgent Applications must be enrolled in terms of the Family Court directives and the rules pertaining to urgency will be strictly applied.
