DIRECTIVES IN RESPECT OF OPPOSED MOTIONS BEFORE YACOOB J

- 1. Kindly note that the matters detailed in the attached opposed motion roll have been allocated to Yacoob J.
- 2. All matters will be heard in open court, unless consensus on a virtual hearing is reached between counsel appearing in the matter, and the court is of the view that the matter ought to proceed virtually. For those matters that will be heard in open court, the parties will be informed of the courtroom prior to the hearing.
- The Caselines file in each matter must fully comply with the requirements of the applicable paragraphs of Revised Consolidated Practice Directive 1 of 2024, in particular, paragraphs 7, 24 and 25. ANY MATTER IN WHICH THE FILE DOES NOT COMPLY FULLY WITH THESE REQUIREMENTS BY 10h00 31 OCTOBER 2025 WILL BE REMOVED FROM THE ROLL.
- 4. Word versions of the heads of argument must also be emailed to MMoropa@judiciary.org.za by the same time.
- 5. Parties must upload their draft orders at least 24 hours before a particular matter is to be heard. A hard copy of each draft order must also be brought to court.
- 6. Where matters are to be removed, postponed, or have become settled, the parties must inform the judge's secretary timeously.
- 7. Parties will be advised on or before 10 November 2025 on which day and at what time their matter will be heard.
