The practice note must be uploaded by 10h00 on 06 October 2025 and an updated roll including dates and times for opposed matters will be published on Monday 06 October 2025 by 13h00. Any opposed matter not allocated must be called at roll call on Tuesday.
- 4. Counsel wishing to introduce themselves may do so at 09h45 on the day of their hearing at the judges' chambers.
- 5. Any matters on the consolidated roll which remain unallocated and in which parties wish to make submissions to request allocation will be dealt with at roll call on Tuesday 07 October 2025 at 10h00.
- 6. Parties are reminded to ensure that they have complied with the relevant practice directives and rules of this court, and that any deviation therefrom is properly substantiated.
- 7. Those matters which do not comply run the risk of not being dealt with, or of adverse costs orders being made.
