**The following processes and procedures shall apply to ALL UNOPPOSED MOTION matters before Randera AJ:**

1. Unless otherwise directed, all unopposed applications will be heard in open Court.
2. The Court number at which the matters will be heard will be published in the normal course.
3. Introductions will take place in court.
4. Matters are to proceed according to seniority.
5. The parties must ensure that all their matters are on CaseLines.
6. If there are reasons why the relief sought should not be granted, the matter must be removed from the roll.

7. Outstanding practice notes must be uploaded to CaseLines by no later than 17h00 on Friday, 17 April 2026.
8. Where certain practice or legal requirements must strictly be complied with before the relief sought is granted, proof of such compliance must specifically be brought to the judge's attention.
9. Draft orders must be uploaded to CaseLines and two copies must be handed up in Court with details of counsel, the date on which the order is granted and the name of the presiding judge. Annexures/ settlement agreements must be attached to the draft order on the day of the hearing.
10. Matters which have been properly enrolled and set down but are not on CaseLines must be uploaded to CaseLines by no later than 17h00 on Friday, 17 April 2026. If this is not possible, different arrangements must be made with Ms. Tsotetsi by e-mail to [MTsotetsi@judiciary.org.za](mailto:MTsotetsi@judiciary.org.za)
