DIRECTIVES (15 April 2026: 16h30)

ALLOCATIONS AMENDED AS OF 16 APRIL 2026 AT 16:00

(Please confirm your allocation with the secretary of the senior judge)

1. Practitioners are reminded that in terms of paragraph 16 of the Insolvency Court Rules, all requirements and procedures applicable to unopposed and opposed motions set out in the Practice Directives and Practice Manual must be fully complied with. These include paragraphs 7, 25 and 26 of Consolidated Directive 1 of 2024, as amended in Johannesburg by the DJP's notice of 22 April 2025 relating to opposed motions ("the CPD"), as well as the DJP's notice of 1 December 2025 ("the bundling notice").

2. Opposed matters on the roll below marked “at risk of striking” are at risk of being from the roll at 10h00 on Tuesday 28 April 2026 in terms of paragraph 25.13 of the CPD due to non-compliance with applicable directives. Parties seeking to avoid this are invited (after having ensured full compliance) to furnish a full and satisfactory explanation for the non-compliance in writing to the allocated Judge in the practice note referred to in para 4 below. Should the allocated Judge be requested to extend any provisional order at risk of lapsing due to a striking, a draft order must be prepared and submitted for that purpose, and practitioners must be prepared to indicate where in the Caselines bundle the most recent provisional order (if any) is to be found. No return date will be extended unless the Judge has been granted Caselines access to the matter. The same will apply in respect of provisional orders at risk of lapsing in matters which have not been enrolled for any reason.
3. During the week of 20 April 2026, the Judges will each publish a roll setting out further directives for the hearing of the matters allocated to them. Due to the curtailed work week caused by the public holidays on Monday, 27 April and Friday, 1 May 2026 (and subject to any specific exceptions directed by the allocated judge), the following shall apply:
 - a. all **unopposed** matters (both non-urgent and urgent) will be heard on **Tuesday, 28 April 2026**; and
 - b. all **opposed** matters (save for those liable to be struck from the roll on 28 April 2026 and urgent matters that must be heard on that date) will be heard on either **Wednesday, 29 April** or **Thursday, 30 April 2026** at times and dates scheduled by the allocated judge.
4. Practitioners appearing in **non-urgent unopposed** matters are reminded to comply with the requirements in paras 26.8 to 26.11 of the CPD to upload: (i) updated practice notes; (ii) draft orders complying with paras 26.7, 34.3 and 34.4 of the CPD; and (iii) short heads (if appropriate) by no later than **16h00 on Friday, 17 April 2026** (i.e. by the date stipulated in para 25.10 of the CPD). It is reiterated that the purpose of practice notes “*is to assist the court in the efficient disposal of the matter*”, which means that they should address not only the aspects referred to in paragraphs 26.7 to 26.9, but also every aspect of the matter that the court needs to consider, with references to specific pages in the Caselines bundle for each submission. Non-compliant matters will not be read and may be struck from the roll by the allocated Judge.
5. Practitioners appearing in **non-urgent opposed** matters are invited to upload a further (preferably joint) practice note by no later than **16h00 on Friday, 17 April 2026** recording any limitations that counsel may have, and any agreed request for a specific time or mode for the hearing, on 29 or 30 April 2026. Such limitations and/or requests will be considered in allocating matters for hearing, but the allocated Judge shall not be bound to accommodate them. Practitioners appearing for each party in **urgent opposed** matters are directed to upload a (preferably joint) practice note by no later than **14h00 on Friday, 24 April 2026** setting out each party’s: (i) brief submissions on both urgency and the merits; (ii) authorities relied on; (iii) estimated duration of argument; and (iv) any limitations or requests regarding the date, time and mode of the hearing and, in particular, whether there is any reason why it cannot be heard on either 29 or 30 April 2026.
6. Representatives in all matters must ensure that the uploading of any document to the Caselines bundle after 16h00 on 17 April 2026 does not affect the pagination of any other document in the bundle as at that time as the allocated judges will be preparing on the basis of that pagination. Further

or amended directives may also be published via “widely shared notes” posted on Caselines file. Parties are required to look out for these communications and respond thereto as requested.
