ALLOCATED ROLL AND DIRECTIVES (20 April 2026: 09h30)

1. Due to the curtailed work week caused by the public holidays on Monday, 27 April and Friday, 1 May 2026:
 - a. all **unopposed** matters (both non-urgent and urgent) will be heard in open court on **Tuesday, 28 April 2026**; and
 - b. all **non-urgent opposed** matters will be heard at the times and dates indicated below.
2. Matters on the rolls below marked "**non-compliant**" are non-compliant with applicable practice directives and will (save in exceptional circumstances) be struck from the roll at 10h00 on Tuesday 28 April 2026 due to non-compliance with applicable practice directives. Should the presiding Judge be requested to extend any provisional order at risk of lapsing due to a striking, a draft order must be prepared and submitted for that purpose, and practitioners must be prepared to indicate where in the Caselines bundle the most recent provisional order (if any) is to be found. No return date will be extended unless the Judge has been granted Caselines access to the matter. The same will apply in respect of provisional

orders at risk of lapsing in matters which have not been enrolled for any reason.

3. **URGENT MATTERS:** As per the directives in the consolidated roll published on 17 April practitioners appearing for each party in any opposed urgent matters that may be set down and allocated for hearing by Moultrie J are directed to upload a (preferably joint) practice note by no later than **14h00 on Friday, 24 April 2026** setting out each party's: (i) brief submissions on both urgency and the merits; (ii) authorities relied on; (iii) estimated duration of argument; and (iv) any limitations or requests regarding the date, time and mode of the hearing and, in particular, whether there is any reason why it cannot be heard on either 29 or 30 April 2026.
4. Further or amended directives may also be published via "widely shared notes" posted on Caselines file. Parties are required to look out for these communications and respond thereto as requested.
