1. Parties must ensure that typed Joint Practice Notes, Heads of Argument, and all record documents are uploaded to the Caseline by 16h00 on Thursday, 16 April 2026. If documents are filed out of time, a condonation application must accompany the late filing/upload of the documents
2. All points in *limine*, points of contention, and aspects on which rulings are sought must be set out in the typed Joint Practice Note.
3. The hearing will be in an open court, 10h00
4. All documents must be uploaded onto Caselines by Thursday, 16 April 2026 at 16:00
5. Parties should bring 2 hard copies of the draft orders to court.
6. Draft Orders should indicate the number on the roll, the date, the judge's name (i.e. Mogale AJ), and at the end of the draft order, the name of counsel and the instructing Attorneys' email addresses and contact details should appear.
