Directives:

1. The Hon. Judge Wanless will hear the matters hereunder in open court on **Friday, 15 May 2026 at 10h00 AM**. (The relevant court number will be disclosed in due course – please see JSA website for daily court allocations).
2. An appearance will be required in all matters (save for those that have been duly removed by Notice).
3. The attention of all parties is specifically drawn to the provisions of the relevant paragraphs of the Judge President's latest Practice Directive dealing with Practice Notes for Unopposed Motions. These are to be uploaded **by Wednesday, 13 May 2025**. The Practice Note should set out all the pertinent issues of the matter and precisely where each may be found on CaseLines.
4. All material documents to be placed before the court, including certified copies of **settlement agreement, marriage certificate**, must be uploaded to Court Online and then made available on Caselines by no later than **noon on Wednesday, 13 May 2025**,

failing which the matter may be removed from the roll.

5. Draft orders must be duly completed and compliant (i.e. must contain the number on the roll, the details of counsel, reflect the date of the hearing, and the Judge’s particulars). Draft orders must be uploaded onto CaseLines, and Counsel must bring a copy to the hearing in court. This order must be signature ready (i.e. remove the word “draft” from the tramlines) **Orders will be delivered by uploading same onto CaseLines for Caselines matters, and on Court-Online for Court-Online Matters.**
6. When moving their matters, counsel will be expected to hand up a draft order in hardcopy.
7. Counsel are excused from introducing themselves in chambers.
