8. Counsel are asked to ensure that all other relevant practice directives are promptly complied with.
9. Documents evidencing that notices of set down have been served on the defendant are filed on Caselines timeously."
10. Matters that do not comply with the directives will be removed from the Court's roll.
11. All material documents to be placed before the court must be uploaded to CourtOnline. The Court Online file must then be made available on the **Caselines** platform.
12. Matters not available on Caselines, or in which material documents have not been uploaded to Caselines, may be summarily struck from the roll.
