TO: ALL LEGAL PRACTITIONERS

1. All applications will be heard in open court, commencing at 10:00. The court roll of 25 June 2026 is attached herein.

 - 6.1 correct case number,
 - 6.2 correct names of the parties involved;
 - 6.3 That the application appeared before Saloojee AJ on the set down date , as well as the number of the matter on the roll.
