2. The roll will be called as follows: Postponements, removals and settlement, followed by order of seniority.
3. Matters that become settled, removed or postponed by agreement must be communicated by email to the Judges Secretary Ms.Leletu Siqola LSiqola@judiciary.org.za without delay.
4. Introductions will take place in court before the Honourable Judge at **10:00am**, unless stated otherwise.

5. If a draft order is to be made an order of court, one hard copy must be brought to be handed up in court. Draft orders, must correctly indicate the Judge's correct particulars, case number, the date of hearing, the court and the correct names and contact details of both Counsel and their instructing attorney.
6. All papers in all matters must be uploaded on case lines. If an application is not loaded on CaseLines, it will be removed or struck off from the roll.
7. A practice note must be filled setting out the following:
 - 7.1 Particulars and contact details of the legal representatives.
 - 7.2 Nature of the relief sought.
 - 7.3 Service of the application should be pointed out.
8. Practice notes are to be uploaded by no later than 16h00 on full court day before the date of set-down.
9. Legal practitioners must before uploading the draft orders on CaseLines, check if the draft order contains the following disclaimer:
 - 9.1 Include the following Disclaimer: *This Order is made an Order of Court by the Judge whose name is reflected herein, duly stamped by the Registrar of the Court and is submitted electronically to the Parties/their legal representatives by email. This Order is further uploaded to the electronic file of this matter on Case Lines by the Judge or his/her Secretary. The date of this Order is deemed to be the [set down date].*
10. Costs are awarded in **PARTY AND PARTY SCALE B**.
11. A draft order should be uploaded to CaseLines, in both PDF and Word format.
