The uploaded draft order must clearly set out the Judge's surname, the date of hearing, the manner of hearing, the names of the counsel and the attorney, their respective e-mail addresses, and the disclaimer hereunder. If the phrase "Further or/and alternative relief" appears in your draft order, it must be deleted.
