5. **Counsel are required to bring a hard copy of the draft order to court. Please ensure that the Judge's surname, date, case particulars and case number are correctly reflected on the draft order.**

The draft order which is uploaded must clearly reflect the surname of the Judge, date of hearing, manner of hearing, the name of the counsel, the attorney and their respective e-mail addresses and the disclaimer. If the phrase "Further or/and alternative relief" appears in your draft order it must be deleted.
