6. The Draft order for **SIC Applications** must include that the Respondent is ordered to comply with the Court Order within **15 (FIFTEEN) DAYS** of service of the order.
7. Further, include that the Respondent is ordered to pay costs in **PARTY AND PARTY SCALE A.**
8. The draft order which is uploaded must further reflect the name of the counsel, the attorney and their respective email addresses and the disclaimer. If the phrase "Further or/and alternative relief" appears in your draft order it must be deleted.
9. Include the following Disclaimer: *This Order is made an Order of Court by the Judge whose name is reflected herein, duly stamped by the Registrar of the Court and is submitted electronically to the Parties/their legal representatives by email. This Order is further uploaded to the electronic file of this matter on Case Lines by the Judge or his/her secretary. The date of this Order is deemed to be the set down date.*
