4. In all UNOPPOSED MATTERS a practice note or, where appropriate, short heads of argument must be filed by 16h00 on Friday 19 June 2026 which deals

with the following issue, (including a caselines reference where the allegations are made);

- a. Service in terms of Rule 4
  - b. Jurisdiction
  - c. Relief sought with compliant
  - d. Reasons for urgency
  - e. Merits succinctly summarised
5. In all OPPOSED MATTERS heads of argument and a practice note must be filed by all parties before 12h00 on Monday 22 June 2026. In matters exceeding 200 pages, annexures included, a joint practice note which complies with paragraph 25.17 of CPD 1 of 2024 must be filed at the time directed herein. Failure of any party to co-operate in the compilation of a compliant joint practice note may lead to punitive cost orders.
6. Opposed matters may be allocated for hearing later in the week after finalisation of roll call and availability of counsel shall not be considered for purposes of allocation.
7. Parties must be ready to proceed at 10h00 on 23 June 2026.
