**FINAL DIRECTIVES AND HEARING SCHEDULE**

**(Monday, 1 June 2026, 13h00)**

1. The final scheduling of the matters allocated to Moultrie J in urgent court for week 8 of Term 2 are set out below. **Notwithstanding the content of any Notice of Motion, parties in matters scheduled for dates and times other than 10h00 on 17 February 2026 need not attend court at that time.**
2. Any further document filed by any party must be both (i) uploaded onto CaseLines; and (ii) emailed to Moultrie J's secretary on the email address above. In addition, all such documents must (save in exceptional cases where this is impossible) be duly filed on CourtOnline before being uploaded onto CaseLines and emailed, and the document uploaded and emailed must be the version of the document that was filed on CourtOnline (i.e. containing the CourtOnline coversheet showing time of filing and watermarks). Representatives must ensure that the uploading of any document to the CaseLines file does not affect the pagination of any other document in the bundle as at the time of uploading
3. Further or amended directives may also be published via "widely shared notes" posted on the CaseLines file. Parties are required to look out for these communications and respond thereto as requested.
4. Save as set out above, paragraphs 24.10 (dealing with return dates for rules *nisi*), 12.25 and 28 of Practice Directive 1 of 2024 (revised 12 June 2024), as well as the Practice Manual will be applied.
5. Any party unable to comply with any of the directions set out above, or becoming aware of any fact that may affect the smooth operation of the court must contact Moultrie J's secretary, copying the legal representatives of the other parties (if any), as soon as they become aware of such inability or fact.
