TO: ALL LEGAL PRACTITIONERS

1. All applications will be heard in open court, commencing at 10:00. The court roll of 13 July 2026 is attached herein.
2. Counsel who wish to introduce themselves can do so in chambers at 09:30 or in court.
3. The roll will be called as follows: Postponements, removals and settlement, followed by order of seniority.
4. All papers in all matters must be loaded on case lines. If application is not loaded on CaseLines it will be removed or struck off from the roll.
5. A practice note must be filed setting out the following:
 - 5.1 Particulars and contact details of the legal representatives;
 - 5.2 Nature of the relief sought;
 - 5.3 Service of the application should be pointed out;

6. Practice notes are to be uploaded by no later than 16h00 on full court day before the date of set-down.
7. Legal practitioners must before uploading the draft orders on CaseLines, check if the draft order contains the following:
 - 7.1 correct case number,
 - 7.2 correct names of the parties involved;
 - 7.3 That the application appeared before Sekoboane AJ on the set down date, as well as the number of the matter on the roll.
