**DIRECTIVE FOR UNOPPOSED MOTIONS BEFORE HONOURABLE JUSTICE JORDAAN
(AJ) ON 07 JULY 2026.**

1. Matters will be in open court starting at 10am on each sitting. Court number is to be confirmed.
2. Introductions will be done in court.
3. Calling for removals, settlements and postponements will be done first.
4. Thereafter, matters will be called in order of Seniority of the practitioner arguing the matter. Should Counsel have more than one matter on the roll, having called the first matter, Counsel will be permitted to proceed to indicate all other matters in which they appear, so that the matters may be called.
5. Kindly ensure that Practice Notes and Draft Orders are uploaded onto CaseLines in both Word and PDF format. A hardcopy of the Draft Order is required to be handed up on the date of the hearing.
6. Draft orders should indicate the number on the roll, the date, the judge's name (i.e. Jordaan AJ), and at the end of the draft order, the name of counsel and the

Instructing Attorneys' email address and contact details should appear and a disclaimer in the following terms:

"This Order is made an Order of Court by the Judge whose name is reflected hereon, duly stamped by the Registrar of the Court and is submitted electronically to the parties or their legal representatives by e-mail. This Order is further uploaded to the electronic file of this matter on CaseLines by the Judge or his/her Secretary/Registrar. The date of this Order is deemed to be 07 JULY 2026."

7. Counsel/Practitioners should ensure that all documents are filed on CaseLines by no later than close of business which is 16h00 on the 03rd of July 2026 for matters being heard on the 07th of July 2026 and 16h00 on the 07th of July for matters being heard on the 09th of July 2026.
8. Uploading of documents on CaseLines outside of the stipulated times and will not be considered and will result in the matter being removed from the roll.
9. Where opposition by the respondent in person is expected (i.e., notice of intention to oppose has been filed or the applicant's attorneys were contacted by the respondent), the applicant is required to contact the respondent and inform the respondent that written submissions under oath should be sent to the abovementioned email address.
10. As soon as an application becomes removed, settled or the parties agree to postpone, electronic notification should be sent to Ms. Rinae Mavhungu and also uploaded onto caselines.
11. Parties appearing in person can come to the High Court Building and notify Ms Mavhungu of their presence in Chamber No 119 at The Palace.
12. If parties encounter any difficulties, they must telephonically contact Ms Mavhungu on 064 652 8111 or approach her chamber No 119 at The Palace.

13. The decorum of the Court is to be maintained at all times.
