 3. Introductions will take place in **OPEN COURT**. **Removals, postponements and settlements** will be called first, following which the roll will be called in order of **seniority**. The **Day Roll** should be consulted for the court allocated for the hearing of the matters.
 4. A Practice Note, complying with the Revised Consolidated Practice Directive and prepared by the legal representative who will appear at the hearing, must be uploaded on CaseLines together with a draft order. **PARTIES MUST BRING A HARD COPY OF THE DRAFT ORDER FOR HANDING UP TO THE COURT.**
 5. Matters that are settled, removed or postponed by agreement must be communicated without delay by email to Ms Mercy Danisa at MDanisa@judiciary.org.za.

6. Legal practitioners must upload the Draft Order (in both MS Word and PDF Formats) on CaseLines. They must ensure that the draft order contains the correct case number, correct names of the parties, the roll number, reflects that the application appeared before **MADAM JUSTICE MARITZ AJ**, states the date of set down, and include the following disclaimer:

This Order is made an Order of Court by the Judge whose name is reflected herein, duly stamped by the Registrar of the Court and is submitted electronically to the parties or their legal representatives by email.
