DIRECTIVES:

1. All urgent applications will have a roll call on **Tuesday, 14 July 2026** in open court at **10h00** and ALL parties in ALL matters are required to be present. Legal practitioners should be ready and prepared to make submissions on urgency and merits.
2. Counsel must ensure that all relevant practice directives are complied with.
3. The Judge invites all practitioners to indicate, should they so wish, by which pronouns they wish to be addressed.
4. Introductions will be done in court.

5. Matters that become settled, removed or postponed by agreement must be communicated by email to the Judge's secretary Ms. Leletu Siqola LSiqola@judiciary.org.za without delay.
 6. If a draft order is to be made an order of court, one hard copy must be brought to be handed up in court. Draft orders and settlement agreements, where applicable, must correctly indicate the Judge's correct particulars, **F BEZUIDENHOUT**, case number and date of hearing, the court and the correct names and contact details of both Counsel and their instructing attorney.
 7. Court orders will be stamped, signed and uploaded within 7 court days.
 8. The court will not deal with matters that were not placed timeously. If your matter was properly enrolled but does not appear on this roll, please contact or approach the enrollment office.
 9. The judge may communicate with the parties' representatives via widely shared notes posted on the electronic file. Legal representatives are to look out for these communications and are requested to respond to such communications.
