3. Postponements and removals are to be attended first. Thereafter matters will be called in order of seniority
4. All relevant documents are to be uploaded and accessible to CaseLines no later than 14:00 2 court days prior to the date of the hearing
5. Counsel is required to provide a draft order in hard copy format to the judge on the day of the hearing which draft order should contain the correct particulars in all respects.
6. The draft order uploaded onto CaseLines must mirror the hard copy of the draft order handed up to the judge.
7. All draft order should contain the following paragraph:

Matters not so removed will be struck from the roll in the case of non-appearance.**
