JUDGE'S DIRECTIVES

2. Introductions will take place in chambers 1006 at 09:45 am.
3. Parties are reminded to ensure that they have complied with the relevant practice directives and rules of this court, and that any deviation therefrom is properly substantiated. Parties' attention is specifically drawn to paragraphs 28 of Revised Consolidated Practice Directive 1 of 2024 and the Family Court Directives for Johannesburg, dated 06 June 2022.
4. Heads of argument, practice notes and authority bundles must be uploaded on CaseLines by no later than 13h00 the day before the hearing or, where answering papers are delivered after that time by no later than 24h00.
5. All draft orders in word and pdf format should be uploaded on CaseLines. Ensure that the draft orders comply with the Court directive and outline the Judges' name, date, mode of hearing including the following disclaimer:
"This Order is made an Order of Court by the Judge whose name is reflected herein, duly stamped by the Registrar of the Court and is submitted electronically to the Parties/their legal representatives by email. This Order is further uploaded to the electronic file of this matter on Case Lines by the Judge or her Secretary. The date of this Order is deemed to be _____."
6. Where matters are settled or are to be removed, ensure that a note to that effect is made timeously on caselines, a notice of removal is served and uploaded and/or a draft order encapsulating the removal terms/ settlement terms is uploaded and handed up to Court.
7. If the matters are not visible on CaseLines and the bundles are not reflecting in order as to the sections on court online, the matter will be removed.
