5. Matters are allocated for hearing in terms of the allocation roll reflected hereunder. The fact that a matter is allocated does not guarantee a hearing as several matters do not comply with relevant practice directives for the hearing of opposed motions. Absent explanation acceptable to the Judge, non-compliant matters will be removed or struck from the roll.
