9. Introductions can be made in court when the matters are called.
10. Please notify our office immediately if a matter needs to be removed from the roll or has become settled.
11. Parties are required to ensure that the full set of pleadings are uploaded, any pleadings filed after 14 August 2026 will require an explanation.
