2. All matters will be heard in **OPEN COURT** at **10:00**
3. Introductions will be done in **OPEN COURT**.
4. Only 1 Draft Order is required to be handed up.
5. Legal practitioners must upload the Draft Orders on Caselines. The Draft Order should contain the date, court and name of the Judge, as well as the name and contact details of the party's counsel and instructing attorney – the draft order should also contain the Disclaimer:

This Order is made an Order of Court by the Judge whose name is reflected herein, duly stamped by the Registrar of the Court and is submitted electronically to the Parties/their legal representatives by

email. This Order is further uploaded to the electronic file of this matter on CaseLines by the Judge or her secretary.

6. A copy of the divorce Settlement Agreement, if applicable, should be attached to the Draft Order sought to be made an order of court.
7. No documents may be uploaded onto CaseLines after **FRIDAY, 4 SEPTEMBER 2026.**
8. All matters must comply strictly with these directives and the Consolidated Practice Directives.
9. Counsel is requested to have regard to the widely shared note function on CaseLines as queries may be raised and/or notes may be distributed using this function prior to the hearing date.
10. The matters are allocated as follow:

MONDAY, 7 SEPTEMBER 2026 at 10:00

All **unopposed divorces** and all **other unopposed family matters**.

Please Note:

- The matters where there are no minor children and there are settlement agreements, may be finalised on the documentary evidence and evidence affidavits, provided that all documents are uploaded to CaseLines. If no evidence affidavit was uploaded, viva voce evidence is required.
- In matters where there are minor children, viva voce evidence is required. The settlement agreements must be endorsed by the office of the Family Advocate.
