3. Introductions will be done in **OPEN COURT**.
4. Only 1 Draft Order is required to be handed up.
5. Legal practitioners must upload the Draft Orders on Caselines. The Draft Order should contain the date, court and name of the Judge, the number of the matter on the roll, as well as the name and contact details of the party's counsel and instructing attorney – the draft order should also contain the Disclaimer:

This Order is made an Order of Court by the Judge whose name is reflected herein, duly stamped by the Registrar of the Court and is submitted electronically to the Parties/their legal representatives by

email. This Order is further uploaded to the electronic file of this matter on CaseLines by the Judge or her secretary.

6. A copy of the divorce Settlement Agreement, if applicable, should be attached to the Draft Order sought to be made an order of court.
7. Parties must bring original marriage certificates in unopposed divorces.
8. Legal Practitioners should ensure that all documents, including the Practice Note, are uploaded onto CaseLines by **FRIDAY, 11 SEPTEMBER 2026, @16h00**. If the same is not uploaded, the matter will be removed from the roll.
9. All matters must comply strictly with Family Court Directives and the Consolidated Practice Directives.
10. Counsel is requested to have regard to the widely shared note function on CaseLines, as queries may be raised and/or notes may be distributed using this function prior to the hearing date.
