DIRECTIVES

1. The Honourable Judge Wanless will hear the matters hereunder in open court on the dates and times stated. (The relevant court number will be disclosed in due course – please see JSA website for daily court allocations).
2. An appearance will be required in all matters (save for those that have been duly removed by Notice).

3. Draft orders must be duly completed and compliant (i.e. must contain the details of counsel, reflect the date of the hearing, and the Judge's particulars). Draft orders must be uploaded onto CaseLines in PDF and Word format, and Counsel must bring a copy to the hearing in court. This order must be signature ready (i.e. remove the word "draft" from the tramlines, delete the "further and/or alternative relief" prayer etc.) The case number MUST be correctly inserted as per the court roll.
4. The attention of all parties is specifically drawn to the provisions of the relevant paragraphs of the Judge President's latest Practice Directive dealing with Practice Notes for Unopposed Motions. These are to be uploaded onto Caselines at least one full court day prior to the date of the hearing. The purpose of the Practice Note is to assist the Court in the efficient disposal of the matter. In the premises, a Practice Note which merely describes what type of matter the Court is dealing with and/or does not refer the Court to the relevant documents and where these are to be found on Caselines, is of no assistance at all. The Practice Note should set out all the pertinent issues of the matter and precisely where each may be found on CaseLines. In this way, the Court will be able to ascertain whether the applicant is entitled to the relief sought or not. **If a Practice Note does not comply with the foregoing the matter will be removed from the roll with an appropriate order as to costs.**
5. **No last-minute appearances at court to oppose a special interlocutory application will be entertained. Notices to oppose should be filed timeously. Where an application is opposed and where the parties have made a real effort to agree upon an order by consent but all efforts have been unsuccessful, the parties must compile a Joint Practice Note and Concise Heads of Argument, clearly setting out the issues and the relief sought. These must be emailed to Mr Manganyi and uploaded on to Caselines, at least one full court day prior to the date of the hearing.**
6. Parties with Court Online matters must follow the "7-Steps" to ensure that their Court Online matters bundle onto Caselines.
7. In matters where it is noted on the roll that there is no bundle created on Caselines, there are no documents before the Judge, therefore the matters will be removed from the roll for non-compliance with the directives.
8. If any parties are experiencing any difficulties with Court Online, parties are to seek assistance timeously from the Court Online helpdesk staff at office 002 to avoid their matters being removed from the roll.
