URGENT COURT: WEEK OF 15 SEPTEMBER 2026

1. Matters will be heard in open Court. Introductions will take place in Court.
2. **The Court sits at 10:00.**
3. Allocations are as follows:
 - a. Matters to be heard on Tuesday: 2, 9, 22, 34, 38, 46, 51, 61
 - b. Matters to be heard on Wednesday: 4, 11, 12, 21, 26, 42, 43, 52, 60
 - c. Matters to be heard on Friday: 20, 30, 35
4. Applications made outside ordinary court hours must be notified to the Judge's Clerk.

6. The Judge's Clerk must be notified immediately once a matter is removed from the Roll. The notice of removal must be uploaded to Caselines.

 - Particulars of the legal practitioners.
 - Nature of the relief sought.
 - A brief exposition on urgency, or lack thereof.
 - A brief summary of the factual and legal issues involved.
 - A bullet-point indication of portion of the papers to be read.
 - How service was effected. Service of process must be in terms of the Rules.
9. Applications that were not filed, indexed and paginated by 14:00 on Friday, 11 September 2026 will not be heard, save with the leave of the Court.
10. Applications without a certificate of urgency and/or without a practice note will be struck from the Roll.
11. All opposed matters must have detailed heads of argument filed by 9h00, the day before the allocated hearing date.
