1. That the Respondent be directed to co-operate in accordance with the provisions of the Revised Directive Introducing Mandatory Mediation and Mediation Protocol dated 9 June 2025, by replying to Plaintiff's Amplified Notice in terms of Rule 41A within 10 (ten) days of service of this order.
2. That the Respondent is declared to be delinquent by reason of its default in failing to engage in Mediation in terms of the Revised Directive Introducing Mandatory Mediation in the Gauteng Division and Protocol dated 9 June 2025 in that it failed to: #
3. In the event that the Respondent fails to comply with the Order in paragraph 1 above, the Applicant shall be excused from engaging in Mediation and the Plaintiff will forthwith be entitled to set the matter down on a separate and prioritized Default Judgment Court Roll, which hearing shall be in the same term/s as the previously issued trial dates and seek the following:
 - 3.1 an order holding the Respondent in contempt of this order;
 - 3.2 an order striking out the Respondent's defense;
 - 3.3 an order granting relief in terms of the Plaintiff's Particulars of Claim;
 - 3.4 an order of costs on attorney and own client scale.
4. The Respondent is ordered to pay the Plaintiff's party and party costs of this application on scale A.
